Tickets are valid for day of purchase. Tickets are non-refundable. All schedules subject to change. Stops may be added to meet demand or overloads. All pickup and drop off times shown are approximate and are subject to delays based on traffic, weather, loading times and other circumstances beyond our control.

Personal Care Assistants: In order to meet the needs of passengers with disabilities, Trans-Bridge Lines allows one Personal Care Assistant to board the bus, without the need of a ticket, when accompanying and/or providing assistance to the disabled passenger.

Guidelines/Rules are as follows: The disabled passenger must present a New Jersey Transit Reduced Fare Card stamped "DISABLED GUIDE". This is the only acceptable form of ID for a Personal Care Assistant. If the ID is not stamped with "DISABLED GUIDE", the person accompanying the disabled passenger must purchase a ticket to board the bus. Drivers cannot delay departures as a result of passengers who do not present the proper ID and who need to purchase tickets to board the bus.
